Nei giorni scorsi la delegazione ligure, in rappresentanza di ICE, Regione Liguria, Liguria International, Spediporto e Ligurian Ports, ha partecipato alla CeMAT India, la fiera internazionale della logistica svoltasi dal 15 al 18 dicembre scorsi a Mumbai, presentando tutte le potenzialità della Liguria ed in particolar modo del suo sistema portuale come porta naturale del mercato indiano. Nel corso dell'evento la delegazione ha incontrato le associazioni degli spedizionieri indiani e l'associazione dei Custom Broker di Mumbai che conta più di 1.500 associati.

L'associazione dei porti liguri ha reso noto che nel giro di meno di un anno il numero di container importati dall'India attraverso il sistema dei porti liguri è raddoppiato e che i dati parziali di traffico 2010 evidenziano che il dato dello scorso è già stato ampiamente superato. (iM)

*Merlo: «Servono accordi bilaterali per intercettare i nuovi mercati»*

Dopo in Nord Africa, che sulla sponda sud del Mediterraneo registra i maggiori ritmi di crescita, il porto di Genova punta sull'India e per il 2011 ha già in programma anche il Brasile. Merlo mette in fila i Paesi con le aspettative di crescita più consistente per stringere rapporti diretti, costruire opportunità per gli operatori che si traducono in un aumento dei traffici e in una posizione dello scalo sempre più centrale come porta di ingresso in Europa che passi anche da un asse con Rotterdam.

I componenti della delegazione della comunità portuale ligure che ha visitato il porto di Nhava Sheva a Mumbai per consolidare la collaborazione avviata l'anno scorso dalla missione Governo - Regioni su portualità e logistica a cui aveva

partecipato anche il presidente dell'Autorità portuale di Genova Luigi Merlo, rientrati da pochi giorni, ha presentato il "sistema" della Liguria e ha incontrato gli spedizionieri indiani e l'associazione dei custom broker di Mumbai che conta più di 1.500 associati.

Ad oggi il traffico fra Genova e l'India non rappresenta una quota elevata del totale, ma il numero di container in import dall'India al sistema dei porti liguri è raddoppiato in meno di un anno e i dati parziali di traffico 2010 evidenziano che il dato del 2009 è già ampiamente superato. L'India del resto è uno dei Paesi emergenti dai quali ci si attendono i tassi di crescita economica più consistente.

«Dopo l'Africa e l'India siamo inseriti il prossimo anno nella missione in Brasile e ho in programma di andare in Marocco per firmare un accordo come


quello fatto con la Tunisia», spiega Merlo. «Sono tutti mercati che crescono in modo significativo. Msc ha fatto un nuovo accordo per una linea con l'India che passa anche da noi».

Il Nord Africa significa i progetti, molto concreti, di sviluppo dei porti e dell'economia: un esempio su tutti il porto di Tangeri con il retroporto che è già stato scelto da numerose aziende europee per insediare le proprie attività.


«Gli indicatori per il prossimo anno prevedono nel sistema mondiale crescute contenute dei traffici, quindi se si intercettano anche piccoli flussi, diventano quote importanti per il porto», illustra Merlo. «La commercializzazione la fanno i terminalisti, ma costruire con questi mercati condizioni favorevoli, andare a spiegare le opportunità che offre la Liguria è il nostro compito. Sull'India operano già

Messina ed Msc, i problemi riguardano la costruzione di accordi bilaterali ad esempio sulla sanità marittima visto che è consistente il traffico di prodotti alimentari. Con il Brasile uno dei prodotti è il caffè, e anche qui bisogna lavorare su condizioni specifiche. Si tratta di costruire agli operatori, ed è un lavoro in abbinata fra Autorità portuale e Spedizionieri, una situazione in cui è il mercato a chiedere un porto di riferimento piuttosto che un altro».

Intanto procede la costruzione della piattaforma logistica italiana nel porto di Tianjin, collegato direttamente a Genova da un corridoio doganale. Grazie all'intesa del 2008 alla fine dell'operazione i container in partenza dal porto cinese, controllati all'imbarco dalle dogane italiane e sigillati non dovranno subire altre verifiche fino a destinazione: una velocizzazione che si tradurrà in un incremento dei traffici.




